In this declaration:

- 'diocese' refers to the Diocese of Gozo meaning the Catholic Church in Gozo.
- The Curia means and embraces all Church entities and sections which administratively fall under the Bishop's Curia.
- Parish refers to the parish/church/centre/community where the programme is being held.
- Parish Priest refers to any priest or religious person or any lay person responsible of this programme.
- DPC refers to the Data Protection Coordinator for Parishes. (dpc.parrocci@maltadiocese.org)
- 'Legislation' refers to the 'General Decree on the Protection of Data (2018)' (GDPD), to the General Regulation on the Protection of Data (EU) 2016/679 (GDPR) and any other legislation or regulation in due force.

We the undersigned parents/guardians declare that we:

- agree with the Children's Catechism programme regulations for which we are submitting this application (hereinafter referred to as the programme) and/or with those of the centre where the programme is being held. This programme includes formation meetings for adolescents up till 2 years following Confirmation for which we strongly recommend the adolescent to attend;
- are aware that this information is being collected on behalf of the Diocese of Malta and that this same information will be held and processed as defined in the General Terms and Conditions for Personal Data Protection in Parishes (hereinafter referred to as Terms and Conditions), according to the ecclesial and state laws. This information shall be processed by various entities/sections of the Diocese related to this programme. For further information on withdrawal of consent given in this form, retention, processing, portability, correction, objection, deletion of data and the right to initiate a complaint with the supervisory authority we can access these Terms and Conditions on the Diocese website (www.gozodiocese.org). We can approach the Parish Priest for further information or to exert these rights;
- are aware that this information is being retained and processed for purposes related to this Catechism programme and other pastoral activities in conjunction to this programme. We know that certain correspondence and our child's attendance shall be kept for pastoral and administrative purposes;
- know that this information can be forwarded to other entities (which are not included in article 1.4 of these Terms and Conditions) for purposes related to this programme;
- declare that all information given in this application is correct and should there be any changes we are bound to immediately inform the Parish and/or Pastoral Centre and/or Catechism Centre (hereinafter referred to as the Parish);
- know that the Catechism Centre may be equipped with security cameras (CCTV) and that these records are kept as stipulated in the Terms and Conditions in line with state law;
- grant permission to the Parish Priest to administer the Sacrament of Reconciliation, First Holy Communion and Confirmation when he deems that our child is prepared to receive such Sacraments. We also accept the collection, retention and processing of all data required for administrative purposes related to these Sacraments for administrative and registration purposes according to Ecclesial Rules and Legislation Internal Rules; ☐ Yes ☐ No
- give permission to our child to attend various activities related to this programme which might be held outside the usual premises; ☐ Yes ☐ No
